### **Minutes**

#### Reflections on weekends 1 & 2

Panel was very impressed with delivery of the weekends to date. Particularly the choreography, facilitation and questions coming from assembly members. Small points raised about distinction between informants and advocates, and some speakers being slightly rushed.

# Sarah talks through broad outline for weekend 3

# Lorraine talks through "What we buy" theme

#### Discussion:

- Discussed the need to consider or define impacts and effects of some of the policies presented
- Need to make sure the distinction between futures is made e.g. whether or not they are mutually compatible - and making links to other themes such as travel
- Discussed international dimensions

# Lorraine talks through "What we eat and how we use the land"

#### Discussion:

- Discussed links with other policy areas, such as planning and biodiversity
- Considered need to expand upon international nature of supply chains
- Discussed how to include considerations around consumer information, and how to make jargon accessible for assembly members

# Becky/Jenny introduce 'in the home'

#### Discussion:

- Discussed technological and cost considerations (e.g. green vs blue hydrogen, and 'who pays' questions)
- Discussed fairness, (e.g. considerations around 'Just Transition' and guarding against urban bias)
- Discussed accessibility for assembly members

### Jillian talks through surface transport

#### Discussion:

- Considered whether road pricing and fiscal measures were given adequate weight
- Discussed wider considerations around planning, tourism and leisure.
- Discussed specific modes and technologies, e.g. active travel and hydrogen vehicles

#### Jim talks through air travel

#### Discussion:

- Discussed the right balance of detail between simplicity and quantitative detail
- Wider considerations behavioural e.g. teleconferencing, financial e.g. carbon tax
- Responsibility/ability of public vs private sector
